\*\*Electric, tables and tents will not be provided by the Ocala Jeep Club of Florida, Inc. You must bring your own tables and tents.

\*\*Any vehicles left on the show grounds after 5:00 p.m. on Saturday must remain there until show opens on Sunday.

\*\* There is NO On site camping available. Please check the website for camping and hotel links.

\*\* You may register on show day for a vendor spot. However, we recommend that you pre-register. It will help expedite the check in process if you pre-register. Also, be sure to complete and return the vendor questionnaire. This will be used to advertise your business throughout the course of the show.
